5. Numerous autonomous mobility pilot projects, making it an ideal testing ground in Europe.

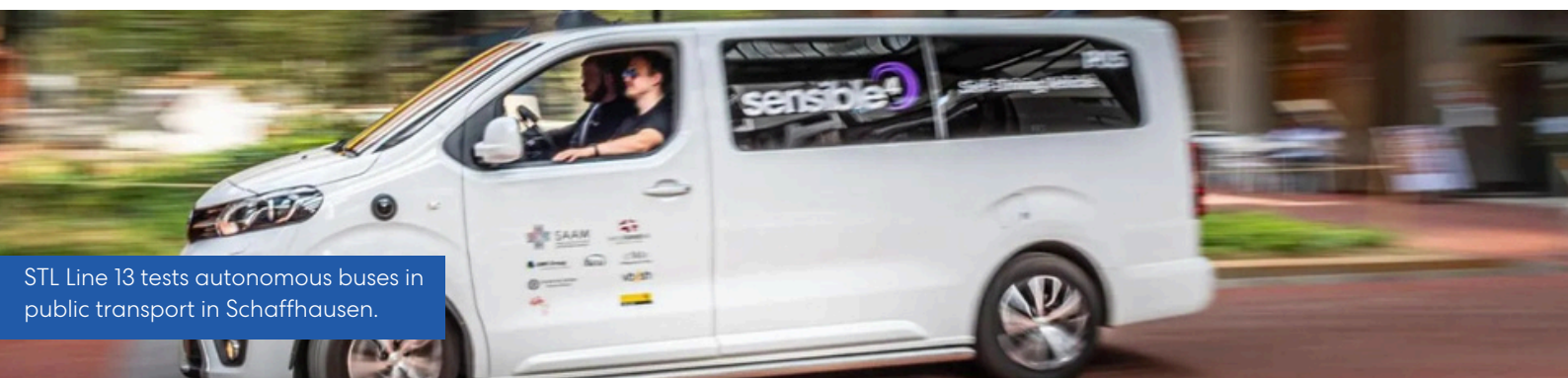
## Favourable regulation

### Electric vehicles

- Switzerland offers several incentives for EV adoption, such as tax reductions in various cantons, discounts from insurance and leasing companies, and subsidies in certain cantons.
- Since 2024, Switzerland abolished customs duties on all imported industrial goods. EVs are subject to a 4% automobile duty, levied on the import price rather than the final sale price.
- Unlike the EU, Switzerland has not adopted additional customs duties on Chinese EV imports.

### Autonomous driving (from March 2025):

- Drivers can use self-driving technology on Swiss motorways but must stay ready to take control.
- Driverless vehicles permitted on specific authorized routes, monitored by a control center.
